

PARKING CODE VIOLATORS FACE INCREASED FINES STARTING FEB 1

People who park illegally in Denver will face increased fines starting in February. This comes after Denver's Department of Transportation and Infrastructure (DOTI) asked People who park illegally in Denver will face increased fines starting in February. This comes after Denver's Department of Transportation and Infrastructure (DOTI) asked the Denver County Court to review the fee schedule for parking code violations and consider increases to encourage compliance with rules that support safety and mobility in Denver.

It has been 15 years since DOTI completed a comprehensive review of parking fines and found median citation amounts for violations were below peer cities.

Denver is increasing fines by \$10 for most parking violations with the exception of a few that directly tie to the City's goals for safety and mobility for residents and visitors.

For example:

- Parking in/blocking a bike lane is going from \$25 to \$65
- Parking in/blocking a sidewalk is going from \$25 to \$65
- Parking in/blocking a crosswalk is going from \$25 to \$65

The fine for parking illegally in an accessible parking space is going from \$150 to \$350, to deter people from illegally using parking areas dedicated to people with disabilities.

Another notable increase deals with large vehicle parking, which is going from \$25 to \$250. The City has seen a rise in large vehicles, such as semitrucks and large business trucks, using residential neighborhoods to park. Not only does this take up valuable curbside space, but it also interferes with the quality, enjoyment, and safety of the people who live in those neighborhoods.

Denver anticipates an additional \$6.4 million in 2022 will be collected under the new fine schedule and placed into a DOTI special revenue fund for mobility and safety improvements.

What is redistricting?

Redistricting is a process that legislative bodies undertake every ten years after the release of the decennial US Census. The purpose of redistricting is to ensure every individual's vote counts in accordance to the Voting Rights Act by evenly adjusting district boundaries based on population and the number of districts without diluting minority voices.

In Denver the goal of redistricting is to create eleven districts that are as evenly-populated and as geographically compact and reasonable as possible to uphold the one-person-one-vote standard in the US Constitution.

Sec. 3.1.2 of the Charter provides guidance for redistricting. The Charter requires Denver to have eleven districts; that districts to be as compact as possible; that districts contain contiguous territory; that districts contain as equal a population as practical based on the most recent US census data; that districts consist of whole voting precincts; and that district boundaries be changed at least once every ten years.

Why is it important?

Redistricting ultimately shapes the political landscape in Denver, and is an important process to make sure the People have the opportunity to choose who represents them. Denver has changed over the past 10 years with an increase in Denverites, new buildings, and amenities. Our council boundaries need to be altered to reflect these changes and how they are represented at the municipal-level. These new boundaries will remain in effect for 10 years, determining representation on important issues until 2035.

 - o Maptitude for Redistricting software requires the collection of Personally Identifiable Information (PII) and will only be used for redistricting purposes. All copies of the PII data provided to City Council must be destroyed by 04/01/2022, at the end of the redistricting process. City Council members have been trained on data privacy and protection, especially pertaining to personally identifiable information and use constraints.

Those who submit redistricting plans are required by City Council to verify that you live in the city and county of Denver. This enables City Council to contact you if they have questions about the plan you submitted. This information will be used explicitly for redistricting and all copies will be destroyed by April 2022, with the City and County of Denver's Technology Services securing a copy for legal reasons. If constituents do not wish to provide this information, please contact your city council representative at redistricting2022@denvergov.org or attend a public meeting to share your thoughts on redistricting.

JEFFERSON PARK IN THE NEWS

Jefferson Park has long borne the ill effects of companies' concepts (Slothomes, Airbnb) until Denver slowly reacts with regulations. Turo becomes the latest company to show how bad actors can exploit their business model to the detriment of Jefferson Park residents.

The following is an excerpt from a story aired on 9news on December 21, 2021

For months, Kevin Hesla struggled to find a parking spot on his street near Empower Field at Mile High. "If you came home after a certain time at night, people were literally parking in the alley," he said. "There was nowhere to park." After a while, Hesla said he started to see people wandering around 21st Street across from his condo. They appeared to be searching for vehicles. "There were just people walking around, people going back to the airport, people standing on our lawn," he said. "I just asked them what app they were using, and they said Turo." Turo is a carsharing app meant to let people rent their vehicles temporarily using a concept similar to Airbnb.

Hesla said he soon found a profile for a man named Ryan who was listing more than 30 vehicles on the app. He looked through the vehicles listed on Ryan's page, and realized those same vehicles were parked on his street. "Basically, our whole street was turned into a rental car lot," Hesla said.

He began to keep track of the cars by license plate, snapping pictures of them and logging where they were parked in a spreadsheet.


Hesla contacted the city about the issue, but said he was told there wasn't much the city could do since Jefferson Park is zoned for mixed use. Both Hesla and Councilwoman Sandoval contacted Turo to see if the issue could be resolved.

It took several months, Turo admitted the host was in violation of the company's Good Neighbor Policy, which requires car hosts to park vehicles on private property, so to not take away public parking.

"Any complaints regarding host parking and vehicle storage are taken seriously and violations may result in restricted vehicles and accounts," a representative for the company said in a statement to 9NEWS. "When Turo's Trust and Safety team received the complaint, the team took swift action to work with the host and local government to enforce the Good Neighbor Policy and resolve the issue." Hesla said the person who contacted him from Turo said the host had been told to move his vehicles to private property. He said the representative told him if the host violated the policy again, he would be removed from the Turo platform.

Denver's Department of Transportation and Infrastructure, which manages the public right of way, told 9NEWS the city may create a new policy to manage this issue.

"DOTI is reviewing its policies that regulate the public right of way and how, if at all, these types of businesses are governed by existing policies," spokeswoman Vanessa Lacayo said in a statement.



Good neighbor policy

The Colfax Viaduct is a critical piece of infrastructure for area connections, and at the same time acts as a barrier to access for active transportation users.




